This report and the statistical information provided by staff is to update you on the current operations of the Board.

a) Administration Update

<u>Staffing</u> – The Board has experienced delays in backfilling the analyst position created by the Business Modernization project workload. We are currently in the process of recruiting for this temporary position to start in June and the position to remain throughout the duration of the Business Modernization Project.

b) **Business Modernization Project**

Since the last Board meeting, Board staff and management continue making progress on the Business Modernization Project. Most recent efforts have been focused on working with DCA's Office of Information Services (OIS) on securing external vendor contracts for web services and SimpliGov solution development who will work with the Board's project lead and owner Tim Yang and DCA OIS. Mr. Yang has worked for the Board in both the licensing and examination unit as well as the enforcement unit and brings a wealth of programmatic and process knowledge and experience. Mr. Yang will be working directly with DCA OIS staff and external vendors to implement the online applications with the oversight of the Board's Executive Officer and Assistant Executive Officer.

The Board was able to secure the necessary contracts in Spring 2022 and will begin the project within the next month. The Board projects to launch its first few applications within the next six months and all initial license applications by summer of 2023.

c) Outreach Update

On March 26, 2022, the Executive Officer and Board members Holly Kaiser and Gilda Dominguez presented at the California Speech-Language Hearing Association Convention in Pasadena during their general session. This is the first time the Board presented at CSHA's General session. The Board received positive feedback and the session was well-attended. Topics discussed included an overview of the Board, the importance of a license, the process of regulations, and current professional and licensing issues that impact the SLP profession.

In April 2022, the Executive Officer provided a licensing update and discussion to California Council of Academic Programs in Communication Sciences and Disorders, made a presentation to the San Francisco State Student Audiology Association, and was a guest speaker during a Hearing Loss Association of America live webcast hosted by their Mission Viejo Chapter.

d) Budget Report

Included in your Board materials is the most recent Expenditure Projection Report (Item 6e). This report reflects fiscal activity through February 28, 2022 and is based on data provided by DCA's Budgets Office. The initial projections in this report will continue to be adjusted to more accurately reflect the Boards projections and actual expenditures. Also included in your materials is the Board's current fund condition which reflects additional revenue due to the most recent fee increases discussed at our last Board meeting.

e) Regulations Report

h) Enforcement Report

The Board has received 97 complaints and subsequent arrest notifications through the second quarter of the 2021-22 reporting year. During this same period the Board has issued four (4) citations and fines. The number of complaints and subsequent arrest notifications have declined in the past two years compared to previous years.

There are currently nine (9) formal discipline cases pending with the Attorney General's Office. The Board is currently monitoring 19 probationers of which four (4) probationers require drug or alcohol testing and five (5) are in a tolled status.
