This report and the statistical information provided by staff is to update you on the current operations of the Board.

a) Administration Update

Board management and staff have been focused on the Business Modernization project and implementation of Apply Simply!, the Board's new online licensing system.

The Board experienced delays in backfilling the analyst position created by the Business Modernization project workload due to several administrative setbacks. We are in the process of reviewing applications to fill this position and hope to hold interviews within the next 2-4 weeks

b) Outreach Update

On September 9-10, 2022, the Paul Sanchez and Dr. Marcia Raggio, Board Chair attended the California Academy of Audiology (CAA) Annual Conference in La Jolla, California. Together they provided a presentation to members of the CAA that included an overview of the Board and focused on the legislative and regulatory processes, and changes impacting the practice of audiology and hearing aid dispensing.

On October 3, 2022, the Paul Sanchez and Cherise Burns provided a presentation which included a demonstration of the Board's Apply Simply! online licensing system to the California Council of Academic Programs in Communication Sciences and Disorders. Most of the State's Communication Sciences and Disorders program directors were in attendance and were able to see the new application system and ask

questions. The Board's program vendors also participated in the meeting and provided technical assistance.

On October 14-15, the Paul Sanchez attended the National Council of State Boards of Examiners for Speech-Language Pathology and Audiology in Santa Fe, New Mexico. The Conference theme was, "Good Governance: Inclusion and Collaboration in the Regulation of Audiology and Speech-Language Pathology." Topics included:

- Diversity, Equity, and Inclusion (in the regulatory space and with consumers)
- National Practitioner Databank Reporting
- Interstate Compact
- Over-the-Counter Hearing Aids
- State Information Exchange

There were about 13 states and one Canadian province in attendance. This conference would benefit from more states participating and providing a remote format since many of the speakers presented remotely. The interaction with other state boards was informative and the discussions on trends in other states was beneficial.

c) Budget Report

Included in your Board materials is the most recent Expenditure Projection Report (Item 7c). This report reflects fiscal activity through August 31, 2022 and is based on limited data provided by DCA's Budgets Office. Based on the limited data available to the Board, at this time, we are unable to provide a complete expenditure projection. The Board will work with the Budget's Office to track this information for planning and budgeting purposes.

Also included in your materials is the Board's current fund condition report. This report is a snapshot of the fund condition and will continue to be adjusted to reflect this year's complete revenue and expenditures.

In addition, staff are in the process of development for the remaining license types for the Apply Simply! online application system that will be released later this Fall and at the end of January 2023.
